A fee of \$950.00 will be charged for the damaged hatch. - No Smoking, a fee of \$100.00 for each carpet or seat burn. A fee of \$25.00 for each broken glass. - Sanitation fee for excessive matter or regurgitation is \$500.00 (NO EXCEPTIONS). - No alcohol consumption by anyone less than 21 years of age, violation could result in early termination based on driver's discretion. (NO REFUNDS) - No illegal drugs or substance use of any kind. -No Food. - Any fines will be paid for by the customer.
